On Tuesday, February 27, over sixty producers from Broadwater and Lewis & Clark Counties joined staff from The Montana Land Reliance (MLR) and

(NRCS) in Townsend to discuss agricultural land conservation easement opportunities.

According to the MLR website, owning a farm or ranch includes the rights to do whatever the owner

wants. He can subdivide, construct buildings, irrigate, harvest timber, restrict access or sell or lease the ground. When a farmer or rancher enters into a conservation easement with his land, he agrees to keep or give up some of those rights to meet the restrictions of the easement. His advantage is he may reduce his income, estate and gift taxes for putting his land in perpetuity under the easement agreement. Conservation

Linda Davis, whose generational family operates a ranch near Toston, said she and her husband, Bob, attended the workshop to learn about the program. She felt easements were "worth considering" but would be a good deal of work and a lot of time invested to get an easement in place. Bob wondered whether he and his family would want to have another partner such as Montana Land Reliance in his operation. "While the program sounds good now, conservation easement policies may change in the future. I don't know if I want to saddle my grandkids with that," he said.

As Broadwater and Lewis & Clark Counties continue to experience rapid population growth, interest in protecting the area's agricultural lands and grasslands is becoming a top priority. Conservation easements are an effective tool in ensuring productive soils and rangelands remain intact and available. The USDAAgricultural Land Easement program, which

is administered through a partnership between MLR and Montana NRCS, provides cash payments to landowners interested in conserving their farms and ranches.

"Montana's farming and ranching heritage is at stake as our state rapidly grows, and Broadwater and Lewis & Clark folks are feeling it as much as anyone," noted MLR Managing Director Kendall Van Dyk. "We don't have to leave the future of agriculture up to chance. As an ag-focused land trust, we want producers to know their options, and help them think through whether a conservation easement is right for them.

During the event, MLR and NRCS staff answered questions about conservation easements and provided insight into the application process. A conservation easement is a voluntary agreement between a landowner and a non-profit land trust that places limits on future development. Conservation easements often include language that protects agricultural lands and maintains open space.

Some Thoughts on County Solid Waste Fees

I'm Bill Jarocki and I'm the Broadwater County Administrative Officer. Since my first day on the job, November 6, 2023, I have been involved with the challenge of sustainably

financing the solid waste operations of the County.

Except for the southernmost part of Broadwater County, residents and businesses are customers of the County Solid Waste District. Solid waste collection and disposal services are paid for through assessments and other specific charges. In government accounting terms, the solid waste operations are managed in an enterprise fund. The reason is that the full costs of service are supposed to be paid for by those who use that service. This is different from general fund services. Think of it this way, if you want to watch Netflix you pay for the monthly subscription.

That's how it's supposed to work. Historically, in Broadwater County citizens have decided (through their elected representatives) to use a sort of hybrid approach. Those in the District pay an annual assessment for service which is added to their property tax bill paid once or twice a year. This system works well if the annual assessments are accurate and actually collected. For the most part, over time most customers paid their assessments and the solid waste enterprise fund had run like a business; costs offset by revenues. And as you would expect, the solid waste enterprise is a not-for-profit business.

But we've uncovered a problem and that's why I'm writing to you. I like to look at the trends of revenues

and expenses so that we can construct an accurate budget. Expenses drive the need for revenue and in solid waste, we look at setting the customer's annual assessment (and other fees) to meet the level of expense. Just so you know my budgeting mantra, it is this: We will provide the best service, at the least cost, to the most people, for the longest period of time.

With all of that as background, here's the bottom line.

Until 2022 solid waste assessment revenues gradually increased as the customer base grew. In fiscal year 2022, we anticipated revenues accordingly. At the close of that fiscal year, our accounting records showed a significant decline in revenue. And when you collect revenue only twice a year, it's hard to see that coming. We had a deficit that resulted from running the business at a loss.

The County Solid Waste Operation didn't overspend. It turns out that not all the customers paid in.

You have a right to ask why. And we're working on it. At the outset, I mentioned that I have been tasked with recommending a strategy to make the solid waste enterprise fund financially sustainable. You'll be hearing more about this project and the work of the team we've put in place to crank out the analysis of facts and data as we focus on this challenge.

We will do the detective work to discover (and explain) why customers had/have not paid their assessments and/ or why the number of assessments had/have changed. Working with the County Solid Waste Advisory Board, the Public Works Department managers and the Board of Commissioners, I will be striving to meet our goal of providing the best service at the least cost for the most customers for the longest period of time.

Agriculture Recovers from Drought

I've heard it quoted many times that farmers are the world's biggest optimists. There are few other industries that have as many variables influencing

the end product. Farmers and ranchers deal with it all. Weather, drought, grasshoppers, market conditions and variable inputs, just to name a few. Yet through it all, they continue to persevere and are always hopeful that next year will be better. 2023 was no different. Just released, the 2023 Montana Agricultural Statistics Report showed that despite challenges, the agriculture industry in Montana is still thriving. The report is published by the USDA National Agricultural Statistic Service (NASS) and the Montana Department of Agriculture with data gathered throughout the previous year from producers, agencies and technicians.

For the first time in Montana's history, agriculture dropped from the top spot as the state's principal industry in 2021, falling behind the travel industry, which increased by 64.1%, likely a result of the post-pandemic travel boom and drought conditions in Montana. However, in 2022, the agriculture industry surged ahead again as Montana's number one industry with \$6.2 billion in cash receipts which is a 43% increase from the previous year. The travel industry remains a close second with \$5.8 billion in receipts.

The report demonstrates how well Montana has rebounded from the drought with a 78% increase in

crop production compared to the previous year. Montana continues to lead the nation as the top producer of chickpeas, lentils and dry edible peas and second in the nation in flaxseed, safflower and durum wheat.

At the local level, Broadwater County had cash receipts of \$17.3 million for livestock (increase) and \$37.3 million for crops (slight decrease). The county has about 296 farms (increase) with a total of 466,920 acres (decrease) in farmland. The average farm size is 1,577 acres. This trend matches the rest of the nation seeing a decrease in farm size.

According to the report, Broadwater County harvested 11,800 acres of winter wheat in 2021 and 11,900 acres in 2022. Broadwater County also saw a slight increase in spring wheat going from 8,900 harvested acres in 2021 to 9,100 in 2022. The county remains one of the top 10 most productive counties in the state in spring wheat producing an average of 32 bushels per acre. Broadwater County is back on the charts in 2022 for barley production as well producing 4,900 acres. We are the fourth most productive barley-producing county in the state at 85 bushels/acre.

Broadwater County has historically been a top producer of hay production as well. However, the current agriculture statistic reports do not provide county-specific hay production data. The state produced 4.1 million tons in 2022 which includes 2.9 million tons of alfalfa hay. This was slightly up from the previous year.

In livestock production, Broadwater County continues to see a downward trend in cattle and calf inventory from 23,000 in 2020 to 19,900 in 2023. A similar trend was seen statewide with a decrease in production to 2.2 million cattle and calves. There was a slight decrease in sheep numbers in the county to 2,100 animals. Statewide sheep numbers decreased slightly as well. Hog numbers held steady at the county and state level with 400 animals in the county.

Broadwater County is one of the smallest counties in the state based on area. Therefore, our county may never rank among the highest in number of acres planted or harvested, but it continues to be one of the most productive. We also have strong diversity as a top producer of seed potatoes and forage seed crops.

Our high production rates can be partially attributed to our fertile valley and network of irrigation canals supplying our crops. Both the Toston and Canyon Ferry Reservoirs were created for irrigation and are still vitally important today. These irrigation sources also help many of our producers be more resilient against drought. This was reflected in agriculture statistics from the last couple of years. Broadwater County saw less decline in crop production due to water availability compared to other parts of the state. Additionally, local farmers remain on top of current technology and integrate innovative techniques to conserve and sustain the farmland for the next generation.

Townsend Trees Planted for Special Purposes

This is the 25th of a series of articles about trees planted and other planting

projects in Townsend and Broadwater County to honor people, special events, or for other purposes. The Tree Board hopes people will come forward with more information on other trees planted on public as well as private property so the tree and its purpose can be documented.

118) Pinus sylvestris; Scotch Pine, one of over 30 trees and 5 different kinds planted by the Toston Blue Ribbon 4H Club and other Broadwater County 4H clubs, the Tree Board, Rotary Club, Broadwater County Lutherans, the Rodeo Club, and many private contractors in April-May 2006 and April 2007 at the Broadwater County Fairgrounds. The tree planting project was funded by a National 4H Council Deft, Inc. grant, Tree Board, Thrivent Financial for Lutherans, and the Broadwater Community Foundation. The Scotch Pines were donated by Nancy Marks. 119) Four trees (Lombardy Poplar, apple, pear, and plum) were planted in the courtyard between the old Cecelia Hazelton Elementary School and the Community Library in July 2005 by the Tree Board, the Townsend School District #1 Summer Camp students, and Jim and Jeff Chamberlain. The trees were donated by Jim Chamberlain at Townsend Hardware Hank. All the trees have died or were removed as part of new school construction in 2021 and 2022. 120) Acer ginnala; Ginnala Maple, planted in May 2007 at the Broadwater Health Center. "Improving Health Care in Broadwater County". The tree was donated by the Broadwater Health Center, Center for Mental Health, and the Broadwater Hospital Auxiliary. The tree was planted by the Tree Board. The tree has died and needs to be replaced. Ginnala Maples do not like our alkaline soil and are not being planted anymore in Townsend. 121) A Butterfly Garden was planted between the old Cecelia Hazelton Elementary School and the Community Library in 2004 by the Townsend School District #1 Summer Camp Students. The flowers were donated by Bryan Flynn. All the flowers were destroyed during the new school construction in 2021-2022. 122) Two Lewis and Clark Gardens were planted with Montana native plants discovered by Lewis and Clark. The gardens were planted in 2005 and 2006 by the Tree Board, the Crimson Bluffs Chapter of the Lewis and Clark Heritage Foundation, and the Broadwater County High School (BCHS) Student Council. The gardens were funded by Crimson Bluffs, two MT Department of Natural Resources and Conservation Mini-School grants, the BCHS Student Council, the Tree Board, and the Montana Native Plant Society. Plaques were donated by the Canton Valley Woman's Club. One garden was in the courtyard between the old Cecelia Hazelton Elementary School and the Community Library. It was destroyed by new school construction in 2021-2022. The other garden is on the southeast corner of the BCHS parking lot by the Townsend Schools boulder near the intersection of Second Street and North Cedar Street. Many of the original native plants are still present in this garden but some need to be replaced. Some the plaques also need to be replaced.

Windows Defender, OneNote and OneDrive come with Windows 10 and Windows 11. Editor and Clipchamp are free but the free versions do not have all of the features of the Office 365 version.

If you do some searching you can purchase traditional standalone versions of Word and Excel; but they are pricey – over \$100.00. Microsoft Office Pro 2019 usually is priced at about \$229.00.

However, you can get an official, license for Microsoft Office Pro 2019 for \$32.00 (plus a 2.99 handling fee) from www.stacksocial.com.

The Office Pro 2019 version comes with Word, Excel, PowerPoint, Publisher, Access, Outlook and OneNote.

- Microsoft Office Pro will be offered at \$39.99 (much



License Key somewhere that you can always access it. License keys ARE important.

Click on the "Download Link" to download the installer. The downloaded installer is a 32-bit installer. If you have a modern PC it will probably be a 64-bit machine. The download process will warn you that it cannot install on a 64-bit machine and ask if you want to install the 64-bit installer. If you get that prompt, choose to install the 64-bit version.

The downloaded installer will be in your downloads folder. Go to the downloads folder and double-click the installer. It will install Microsoft Office 2019 for you. It is large so the download time is long – BE PATIENT.

Once the installation has completed you can launch any of the Office Pro products (Word, Excel, etc.). They will ask if you want to activate your product. Answer yes and that you want to access it via the internet. All of the Office Pro products will be activated.

Now you can use Microsoft Pro 2019!

Note: of course, Microsoft Pro 2019 is an older product and probably will not have all the features you can get in Office 365. It is still supported by Microsoft, but support will probably end in a year or two.

Pam and I used Microsoft Office 2007 for over 15 years with no problems. I have been using Microsoft Office 2019 for several years. As a matter of fact, until recently one of the MT43 News laptops was being used and still had Office 2007 on it.

If you are willing to live with the older version of Office Pro it is a really good deal!

Is it Turkey Season Yet

Eileen Clark Rifles and Recipes

This recipe comes from a famous but no-longer open hunting lodge in Alabama owned by the Pittman family and may be the easiest I've ever cooked. It's also one of the easiest to remember. If you don't have fresh marjoram, improvise with fresh basil, sage, oregano or tarragon. According to clan patriarch, Robert Pittman, the important thing is to simply use fresh herbs and real butter.

PS: Robert's son, Bo, is the author of my favorite rule of hunting, but you must read it with a strong Alabama accent: Bo said, 'Don't go stompin' around in the woods or you will booger it up." Same goes for using dried herbs or margarine in this dish.

Robert P's Quick Sautéed Turkey Breast serves 2

Ingredients

- 1 pound boned turkey breast, in bite sized pieces
- 1/2 teaspoon salt
- 1/4 teaspoon white pepper
- 2 tablespoons butter

Cooking

1. Dry the turkey bites with paper toweling, and season with the salt and pepper.

2. Melt the butter gently in the pan, over medium heat, until it starts to sizzle. Add the turkey chunks, marjoram, chives and parsley and sauté the meat, stirring as it cooks to make sure all sides of the chunks are covered with the herbs and butter and cooked to about 165F, about 4 to 5 minutes at most.

3. Arrange on a platter over rice or egg noodles, and serve with fresh asparagus.

Hiring event: Entry-level wildland firefighter positions

Learning to fight wildfire can be a rewarding job. If you are interested in becoming a firefighter, you can attend a two-day in-person event in Townsend to sign up.

From March 4 through March 15, the Helena-Lewis and Clark National Forest will be accepting applications for twelve entry-level permanent wildland firefighter and dispatcher positions.
