A Sure Sign of Spring Round Grove Ranch Sheep Head Home

Spring in Broadwater County is always heralded by Round Grove Ranch sheep coming home from winter pasture to be shorn of wool and give birth to lambs. This year's event took place on March 14.

Crossing the railroad tracks on River Road and then the Missouri River bridge is fraught with danger and involves many people and lots of coordination. Kelly Ingalls, one of the ranch owners, first arranges with BNSF Railroad to halt train traffic for an appointed time. He also coordinates with the sheriff's office to stop vehicular traffic on both ends of the bridge for the five minutes or so that it takes to herd a band of sheep across the bridge. All moving parts must come together.

This time, as usual, it went well. Kelly, his wife Kay, their son Louis, a herder who hails from Peru,

and a half dozen or so well-trained dogs got it done like clockwork.

It is a special sight to see the dogs work as a team as they gently move the sheep without letting them linger, or stray. Very quietly the sheep move, their hooves clicking on the concrete bridge deck. The dogs are quiet, but they listen intently, ears up, for the shepherd's command. He gives a shout. The lead dog, Chavo, turns onto Mill Road. The crew heaves a sigh of relief as the task is finished. Cars and trucks pick up

speed across the bridge. A tense moment has passed.

And it will happen again, this time in reverse order, in the fall when the sheep are herded back to winter pasture near Lone Mountain after a summer of growth on the Round Grove home ground on the east side of Canyon Ferry Reservoir.

The Round Grove Ranch, headed by Kelly and his brother John, has run sheep and cattle for generations. Kelly's and Kay's two adult children Louis and Ellie are fourth generation.

Townsend Elementary to Pilot Standards-Based Grading

Elementary Principal Christina Hartmann shared plans to pilot standards-based grading for students in kindergarten through fifth grades for the 2024-25 school year during the March 12 Townsend Schools Board of Trustees meeting. Information about the change was also shared with parents during the K-2 parent-teacher conferences on March 19

Standards-based grading measures student performance in specific areas of reading and math against "power" standards: what a child is expected to be able to do in each subject area at the end of a grade level. Montana's Office of Public Instruction (OPI) sets the state standards. Standards at each level for English Language Arts, which includes reading, can be found at OPI's website here: https://opi.mt.gov/Educators/ Teaching-Learning/K-12-Content-Standards/English-Language-Arts-Literacy-Standards#97822720-montana-

Hartmann used the example of where kindergarten students stand relative to being able to count to 100 by the end of that year of school to describe a math power standard.

"We'll be able to tell parents exactly what a child knows," Hartmann said.

A sample grade report provided to parents explains that students will receive a numeric assessment of their progress toward each power standard:

- 3 Consistently Demonstrates
- 2 Sometimes Demonstrates
- 1 Not Yet Demonstrating
- N/A Taught but Not Assessed.

While grades will be reported at the "power" standard level, teachers will also track student progress on the sub standards leading up to the reported skill, Hartmann said in a later interview.

Using the example of the second-grade reading power standard, "Use a variety of strategies to decode grade level words in isolation and in context," on the sample report, grade reports would show parents if and how consistently their child demonstrates that skill. The child's teacher might also be evaluating the student's skill with specific strategies.

For the spring of 2023-24, standards-based for reading will be presented alongside traditional grade reports. Based on parent and staff feedback, the pilot would move forward with the proposal of a change to the district's grading policy for elementary students to allow progress toward reading standards to be reported during the 2024-25 school year.

In a related interview, Superintendent Susie Hedalen said changes to state law made by Senate Bill 8 (SB8) in 2023 increased schools' flexibility to use standardsand proficiency-based progress reporting of student achievement.

Hartmann said in a separate interview that in addition to evaluating the effectiveness of the reading pilot, her team will also be looking at the implementation of standards-based grade reporting for math during the 2025-26 school year.

At this time, Hartmann said, there is no initiative to change grade reporting for the middle or high school. Also on March 12:

- Trustees tentatively approved the addition of high school baseball as an activity for the 2024-25 school year (see related story). Those proposing the addition will need to raise an estimated \$20,000 in start-up and general costs for the first year of the program. Should the program prove popular and successful, the board will continue the sport, providing funding for 2025-26 and beyond.
- Citing state open-meeting law requirements that live-streamed public meetings allow for real-time public comment and response, trustees voted to end live-streaming board meetings via YouTube in favor of a video to be posted on the school website within 24 hours of meetings.
- Board Chairman Jason Noyes clarified that the current trustee election is for two, three-year terms and one, one-year term. Candidates must file for one of the three. The three-year seats are currently held by Noyes and board member Vanessa Flynn; Daniel Truesdell holds the one-year seat.
- Long-time Townsend educators Kim Gilligan, Wendy Gravely, and Allan Sevareid will retire at the end of this school year. Also leaving the district are assistant volleyball coach Jennilee Bird and custodian Steve Ojeda.
- Radio station KDGZ will convert to a streamingonly format in the coming months. Superintendent Susie Hedalin said, "It seems financially responsible to let the radio go," as county Disaster and Emergency Services no longer has a need for a live radio broadcast platform and the low response to surveys of listener behavior. Music and live sports broadcasts will still be available via a streaming app. High school media classes will also utilize the streaming platform for classes.
- Community and school staff are invited to join the board's second strategic planning session from 4-6 p.m. on Thursday, April 4, in the community. The second session will focus on identifying a long-term vision for the district and significant goals.

It will take approximately 45-60 minutes to complete the developmental screener and will be held in the community room near the library.

Please note: Townsend School District is exploring HB352 which is an early literacy program, PreK program, designed to provide targeted interventions. The PreK program will be eligible to children who are 4 years of age or older on or before September 10, 2024, have not completed Kindergarten, and will not be proficient in reading by the completion of 3rd grade based on a development trajectory supported by a research-based assessment. If your student qualifies for kindergarten based on age but may not be ready, please register for kindergarten. Following Kindergarten Roundup, the district will be able to provide further information on the early literacy program, PreK, and if it will be available.



Wood Chastises Commissioners for Treatment During Family Transfer Review

During the open public comment period of the Wednesday, March 13 Broadwater County Commissioners Meeting, Mark Wood read a letter asking that the commission publicly apologize to him and to two other property owners who appeared at the March 10 meeting to request approval of family property transfers.

"In the hearing, my integrity was called into question," Wood, a long-time Broadwater County Sheriff's Deputy said. "I was treated as a defendant on trial."

Wood said he was surprised to be required to speak to the board under oath about the circumstances preceding his family transfer application.

The family transfer process allows a property owner to make a one-time gift of a parcel of property to a spouse or immediate family member. Unlike a typical subdivision of private property, the transfer is not required to undergo review by the county planning board, leaving the county no way to evaluate impacts to a host of potential problem areas – from water and soil to schools and surrounding property owners.

During the March 10 meeting, Commission Chair Darrel Folkvord repeatedly stated his dissatisfaction with the statute, the opportunities for it to be used in ways not originally intended by the legislation, and the idea that statute allowed for a simple work-around to the county's governance of the subdivision process in its borders.

"I thought I was doing the right thing," Wood told the commissioners. "I never had the intent to circumvent the subdivision process."

Commissioners did not respond to Wood's request during the March 13 meeting. No response was received to a request for comment on this story.

Also in the March 13 Meeting:

• Vic Sample, Broadwater County's representative for Southwest Montana, the non-profit destination management organization aligned with the Montana Department of Tourism's 9-county tourism region, brought a potential tourism and recreation grant opportunity to the commission. He asked for Broadwater County Planning Director Nicole Brown's participation on the project's steering committee if the grant is received.

He explained that the department's Pilot Community Tourism Grant Program has 13, approximately \$2.7 million grants available for shovel-ready projects throughout the state. The grants would not require a match from local governments.

"This is a huge grant program for rural communities," Sample said, noting that larger communities like Helena or Great Falls are not eligible to apply.

Southwest Montana identified completing Phases 4 and 5 of the Silos Recreation Area Master Plan as a likely candidate for the grant, Sample said. While other communities in the region also have projects they are looking into applying for, Sample said the Silos project, which includes the development of day-use facilities near Seaman's Bay, just north of Broadwater Bay on Canyon Ferry Lake, has a number of advantages.

In addition to having completed initial planning work, the Silos area shows strong potential for regional participation. Southwest Montana would like to see participation from Visit Helena MT and the Helena Chamber of Commerce, should the application be successful. Interest in placing fire and search and rescue resources in the area as well as the highway department's plan to continue widening US HWY 287 to a four-lane road show "that area is being considered a key area by a lot of different entities," Sample said. He

added that area residents are also in favor of providing better facilities for day-use.

Commissioners approved Brown's participation on the steering committee, should the grant application be successful.

- The board approved the interlocal agreement with Townsend K-12 Schools District #1 for the operation of Broadwater School-Community Library. Superintendent Susie Hedalen said the revised agreement includes language indicating that the library board can not operate separately from the school board. State law does not allow the library board to have the authority to adopt policies that contradict school board policy, she added. While commissioners had some questions about how the library budget was reported to the county and distributed between the school and county, as well as how the county can legally meet its obligation to levy funding as described in the agreement, they approved the interlocal agreement following counsel from Deputy County Attorney Kay Minor. Minor told commissioners that since the interlocal agreement was a broad working understanding between the school and county, the details of budgetary reporting and distribution could be addressed
- outside of approving the agreement itself.

 Commissioners passed a resolution formalizing the county's non-household solid waste fee schedule. County Public Works Director T.J. Graveley said the fee schedule is nearly the same as in previous years. However, now that a scale is available at the Indian Creek station, it will be used to determine the weights of materials deposited at the station. The fees represent about \$70,000 of the of the Public Works enterprise fund, which Graveley said is essential to his being able to manage that fund as a business. Solid waste fees will be posted at the dump site and available on the county's website.
- Ruby Taylor, county public health director, asked for commission approval of a letter of application for Montana Department of Health and Human Services (DPHHS) funding. Taylor said the approximately \$41,000 request would come for state COVID funds that must be used and may be used for non-COVID-related projects. Representing a significant increase in health department funding, the money would allow Taylor to utilize department staff for several initiatives instead of relying on a contract worker. Commissioners approved the funding request application.
- Great West Engineering of Helena received approval to assist the county in its application for a Montana Bureau of Mines and Geology Groundwater Investigation Project (GWIP) for southern Broadwater County. Commissioner Lindsey Richtmyer explained that, if approved, the project would constitute "a very in-depth study" of the groundwater and related geology. The data, she said, would help the commission better understand the potential impacts of residential, commercial, and agricultural land use in the study area.
- The commission approved the City of Townsend's requests to waive a six-month notification period for ending an interlocal agreement to operate Townsend Airport and to transfer the city's interest in land at the airport to the county. "The city has decided they do not want to participate in the airport anymore," Folkvord stated, Commissioners approved both the waiver and the transfer, officially ending the long-standing joint management of Townsend Airport.
- Commissioners signed a contract with Canyon Enterprises to operate the Silos Recreation Area boat docks. Commissioner Debi Randolph said the contract was virtually identical to that between Canyon Enterprises and the county for previous years' management. She added that 2024 will be the final year of the county's direct oversight of operations there, with the area to be turned over to the

US Bureau of Reclamation. Randolph also highlighted that the contract is not related to the Silos KOA.

Lacey Forrey, co-chair of the County Parks and Recreation Board, notified commissioners that Jennifer Dalrymple had been selected as Parks and Recreation Board Chair. Dirk Gard and Phil Duede have been added as board members. Forrey also informed the commission that the vault toilet to be installed at Connors Field has been completed and can be installed once the site is ready. Connors Field President Mike Delger explained that the toilet would be installed east and south of the concession stand, with concrete walkways to allow for wheelchair access to the facilities. Forrey noted she had received significant volunteer interest in completing the work to install the toilet. Delger asked if the county Public Works Department would be able to prepare the site once the outlines were marked. Both Forrey and Delger's questions will need follow-up on

the part of the county before a date for ground work and installation is set.

- Broadwater County Noxious Weed and Mosquito Coordinator Jessica Bushnell presented the commission with the weed board's updated bylaws. She noted that the format was updated to be consistent with the bylaws of other county boards, with no other significant changes. Commissioners accepted the updated bylaws.
- Todd Kitto, Gord Pearse, and Weston Munns were approved as members of Broadwater County's Noxious Weed Board. Their terms expire in December of 2026, 2025, and 2024.
- Hangar space at Canyon Ferry Airport will become more costly, under a fee increase approved by the commission. Rates will increase by 4.34 percent to 12 cents per square foot. Folkvord said this brings the lease rate in line with the rates at Townsend Airport.







In February the TFAA Crew received training in HIPPA, Professionalism, Bloodborne Pathogens, and doffing. Doffing is the removal of personal protective gear safely so as to avoid an exposure to the EMT and this gear also protects the patient. This training was presented by Riesa Overstreet RN. We began the Red Cross Emergency Medical Re-

sponder Course in mid-February. The EMR course is 56 hours of classroom and 10 hours of practical hands-on training. This class, with three students, will be completed in mid-March.

TFAA hopes to gain several new trained EMRs that will be able to aid our EMTs on emergency calls. Later in the summer, we will offer an Emergency

Medical Technician Course. These new folks will be able to bridge the course and move up to EMTs! We hope more folks in our community can step

up and take the full Emergency Medical Technician Course. More information on dates and prices to follow Our EMTs attended four days of training with Jef-

ferson Valley Emergency Medical Service. February 22 to February 25. AMR covered our service area for

"By focusing on specific scenarios like pediatric hypovolemia, we're ensuring that our healthcare professionals are not





Mahony, E.B. Townsley, Ezra Watkins, Chas, Watkins, L.W. Middleton, Jack Call, Reed Schmidt, John Gruar, Frank. T. Hooks, E.R. Vickery, J.K. Doherty, James Egan, Len L. Lefler, J.O. Gross.

In July 1920 J.B. Cates, better known as Ben Cates, resigned as Post Commander and F.G. McCarthy was elected as Post Commander succeeding Cates; McCarthy, having been the first Adjutant, E.R. Vickery was elected to succeed McCarthy, thus becoming the second Post Adjutant.

In listing those members who were either charter members, or early day members, the list is not complete as the early records of the Post pertaining to membership, have been lost and no complete record is now available.

Eileen Clarke Rifles and Recipes

We've decided it may be time to un-lock the hubs on at least one vehicle—it's beyond bad luck to un-winterize both trucks so soon—so I'm thinking it's also time to clean up a winter's worth of 'decorative' crabapple droppings from the grill. Then I'll take the wire brush to the cooking surface, check the little holes on the burners, and check the venturi tubes for insects that may block the propane. What else? Oh yeah. Fill the tank. Empty the grease tray.

Grab a cookbook.

One of the really convenient things about writing cookbooks is you get to consolidate all your favorite recipes into a logical, indexed order, and keep them right by the stove. This morning I picked up Slice of the Wild, looked through the color photos and decided on a one-dish kabob meal. It starts with some chunks of big game meat, with a tasty, easy-to-mix marinade, and thick slices of onion, chunks of potato and juicy slices of bacon, skewered and cooked on the grill. Need a bit more side dish enhancement? From sweet and sour coleslaw, refrigerator pickles, scalloped pineapple and several different potato and pasta salads to the grilled

sweet red peppers in the photo, Slice has 40 of them.

For those who don't cotton to super-sweet barbecue

sauces, this mustard sauce makes a vibrant statement. And it's perfect for our First False Spring when 70-degree days can follow a week of blowing snow.

Old World Marinated Venison and Potato Kabobs

Serves 4-5

Ingredients

1 pound venison, cut into 2-inch chunks

1/4 cup malt vinegar

2 tablespoons brown sugar

2 tablespoons prepared Dijon mustard 2 tablespoons oil

1/2 teaspoon coarse black pepper

1 pound new red potatoes* 1 red onion, sliced thick

4 slices bacon

Preparation

- 1. Trim the steak chunks, and dry with paper towels.
- 2. In a resealable plastic bag combine the vinegar, sugar, mustard, oil, and pepper. Add the meat, and refrigerate 24 to 48 hours.

Cooking

- 1. Preheat the grill to medium-high heat.
- 2. While the grill heats up, microwave the potatoes

on high for about 2 minutes, or until just fork tender, but still firm enough to be able to put on the skewer. Remove the meat from the marinade and arrange on the skewers, alternating with the potatoes and onion slices and threading the bacon along the skewer as you

add ingredients. 3. Cook about 2 minutes a side, until the bacon is browned all over, turning four times. Remove from

the skewers and serve hot, with more mustard. *You can cut up mature potatoes for these kabobs, but new potatoes have better flavor and can be nuked
