Chess is a game that takes great concentration and quiet surroundings. Quiet surroundings were not the case Thursday when the annual Townsend Middle School chess tournament took place in the high school gym.

The entire classes of seventh and eighth graders were on hand to hoot, holler and clap as their classmates appeared as rooks, pawns, knights, bishops, queens and kings. The chess board was a carefully laid out square the size of a garage floor.

Middle school math teacher Gary Bauman has taught chess to middle schoolers for many years, “at least twenty,” he said. He said the idea came from kids who were reading or watching the Harry Potter Sorcerer’s Stone tale, which featured a life-sized chess match.

Bauman said he teaches chess just before Christmas break, then when the students return, those who are interested practice chess during their noon hour from January to March to get ready for the tournament.

Bauman has a method to his chess game madness. “I use chess in the classroom to give kids a chance to improve their problem-solving skills,” he explained. He said studies have shown there is a direct correlation between playing chess and performance in the classroom. Bauman uses the tool as something students can do when they finish their work. He said at the end of most class periods there are one or two games being played. Twenty-eight seventh graders and twenty-four eighth graders participated over the three-month period.

Winners of the eighth-grade class were Reese Wright, Ava Boaz, and Konnor Swan, while Alex Weiss, Isaac Brakefield and Lucas Davies were the seventh-grade winners. Reese Wright went on to win the tournament championship.

## Backyards of Broadwater Supports Community Organizations

Since 2017, Backyards of Broadwater has given over \$3,000 back to local organizations and projects in Broadwater County to support horticulture, gardening and tree activities. This money comes from proceeds from the annual yard and garden tour. 2023 was a record year with 99 tickets sold. Backyards of Broadwater recently reviewed the grant applications from the 2023 event proceeds and is announcing this year’s recipients which are Broadwater FFA, Broadwater County Social Services Committee and Townsend Tree Board.

Broadwater FFA is a school-based youth organization for students interested in agriculture and leadership. The FFA program along with students in the horticulture class at Broadwater High School operates a greenhouse at the school. They provide produce for the school cafeteria. They are currently supplying microgreens which has been ongoing since the beginning of the school year. Their goal with the grant funds is to be able to expand the amount of student-grown produce for the cafeteria to once or twice a week. This program provides an opportunity for students to have access to healthy locally grown foods. It also instructs students in the program about raising their own food.

For the first time, the Broadwater County Social Services Committee is also a recipient of the grant funds. This committee provides funding and support for the Harvest of the Month

program at Townsend Schools. Through this program, students in Broadwater FFA visit the elementary school to share information about a fruit or vegetable each month, often highlighting Montana-grown foods. The FFA members lead educational activities to teach students about how the food is grown, nutritional benefits and cooking. All students get to sample a recipe using the food product from the harvest of the month.

Last, but certainly not least, Backyards of Broadwater supported the Townsend Tree Board. This is a volunteer board overseen by the City of Townsend. They are responsible for managing the urban forest through tree planting, pruning, education, maintenance and care. The chairman of the Tree Board is Patrick Plantenberg. He coordinates community volunteers to get work done and can often be seen around town pruning and planting. He also makes arrangements to water trees during the summer.

Congratulations to all of the recipients! The date has been set for the next Backyards of Broadwater Tour on Saturday, July 27th. The committee is currently seeking gardens to be on the tour which will focus on the east side of Canyon Ferry Lake. They are looking for yards and gardens in the City of Townsend and in close proximity to Highway 284. Many people are worried that their garden isn’t “perfect,”

## City Projects Rising Water Rates

Reporting on a meeting with the city’s bond counsel and Montana State Revolving Fund, Mayor Vickie Rauser told Townsend’s City Council on March 19 that planned increases to the city’s water rates may need to happen much sooner than planned. The final amount city water users could pay monthly will also likely increase, Rauser said, as engineers’ final estimates for costs associated with replacing the water

tower and other needed water infrastructure improvements, are likely to increase as well.

“Rate changes have to be in place when the bond closes,” Rauser said. “We may not have the luxury of phasing them in over time.”

The council was hoping to phase in water rate changes to pay back the cost of bonds issued by the State Revolving Fund. As it stands, Rauser said, there’s a possibility that the bonds may close as early as October of this year, with the system to be in place in late December.

Council member JB Howick asked Rauser to confirm costs and dates as soon as possible.

## Southwest Montana Academic Olympics

Southwest Montana middle school and high school students challenged one another at the annual Southwest Montana Academic Olympics on Tuesday and Wednesday, March 12-13 in the Strand Union Ballrooms at Montana State University. As many as 600 brilliant students representing over 20 schools from all over southwest Montana competed in teams testing their command of general knowledge including, but not limited to science, social studies, mathematics, and language arts. Each round consisted of two five-person teams answering questions head-to-head delivered in a jeopardy-like format utilizing a buzzer response system.

The middle school students were up first on Tuesday, March 12th. Townsend Middle School sent three teams to contend and they certainly showed well, with each team winning at least one match-up. Team A consisting of 8th graders Ayden Thompson, Ava Boaz, and Emma Delgado, as well as 7th graders Clayton Rice and Alex Weiss won 3 rounds and lost 2. Team B was made up of 8th graders Ethan Faas, Tia Tallwhiteman and Adelyn

White, 7th graders Harley Cox and Lucas Feller and 6th grader Rigo Delgado. They won 2 and lost 2 matches. Team C consisting of all 6th graders went 1 and 2, but was one question away from winning their last round. Team C was Andrew Beatty, Kathryn Six, Dannika, Gabe Krueger and Teagon Kraft.

The high school competition followed on Wednesday with Broadwater High also sending three teams. Team A consisted of Senior Cooper Hines, Junior Jazlyn Martin, Sophomores Harper Wolfgram and Noah Borrer and Freshman Angel Sentinella. Making up Team B were Seniors Luci Horne and Caleb LeLacheur, Junior Karsyn Sangray, Sophomore Lexi Davies and Freshman Shalyn Sentinella. The C teams were Seniors Berlin Korr and Tampsen Kockler, Sophomores Aspen Slyker and Merick Easter and Freshmen Kyla Meissner and Ryan Christianson.

Prior to traveling to MSU for the team competition, the students complete a written test of 100 questions. Results are unknown until arrival at the team contest. Two middle school Bulldogs received special awards from that written test. Ayden Thompson was 4th overall in the 8th grade division while Rigo Delgado, a current

## Middle School Track & Field

With the spring thaw comes the beginning of the track and field season and from the recent flurry of activity behind Broadwater High School, it is alive and well. The high school squad this season consists of a mighty 18 boys and 21 girls; the largest team in recent memory.

Taking the helm this year as head coach is Angie Tew. She takes over the head job from Travis Rauh, who led the Bulldogs for more than two decades, but do not think she is new. She has been an assistant coach at her alma mater for the past 19 years, specializing in the sprints and hurdles. She heads a team of veteran coaches beginning with long-time throwing coach and retired teacher, Pat Hamilton who begins his 30th year.

Training the distance runners is Brooke Dolan, who also coaches the successful cross-country program in the fall at BHS in her 14th year. Rounding out the coaching team is Principal Brad Racht along with his wife and middle school teacher, Missy who guide the jumpers.

The track events are the running events and can be divided into three categories: sprints, distance, and relays. The sprints include the 100-, 200-, and 400-meter dashes, as well as the 100/110-meter hurdles and 300-meter hurdles. The distance races include the 800-, 1600-, and 3200-meter runs, roughly measured at one-half, one and two miles, respectively. There are generally two relays at the high school level. In the 4 x 100 relay, the handoff must be done with precision to get the best times possible. The 4 x 400 relay is generally the last event of any meet and may determine

the team trophies.

The field events can be split into two categories: throws and jumps. The throwing events include discus, shot put and javelin. The long jump and triple jump are the horizontal jumps, while vertical jumps would include the high jump and pole vault (although BHS does not have a pole vault due to a lack of a pit).

Each athlete can compete in up to five events, which includes both track and field, at each meet. For some super-talented Bulldogs, that can be a limitation, as according to Coach Tew, many of her squad could be competitive in more. That is why you will see some athletes switching up their events from meet to meet.

This hard-working and talented group of kids will kick off their season by traveling to Frenchtown on March 28th. Good luck Bulldogs!





The criminal docket in Judge Christopher Abbott's courtroom on Friday, March 22 is as follows:

Daniel Rowe had a Scheduling Conference. His appeals case came back from the Supreme Court, saying he should be re-tried. His Omnibus is due on May 25; Pre-Trial is set for July 26; with Jury Trial scheduled for August 19.

Jon Thompson had his Jury Trial vacated; the victim (his wife) has passed away from an unrelated illness.

Jeremiah Howe had his Pre-Trial Conference. His Jury Trial will commence on April 8.

Kyler Stewart had his Petition to Revoke continued until May 24.

Justin Henderson had his Pre-Trial Conference continued until March 29.

Ashley Collins had her Pre-Trial Conference continued until April 19.

Everett Mierow's new dates are set; in anticipation of a Change of Plea on a 'global' disposition. Pre-Trial is set for July 26; with the Jury Trial scheduled for August 19.

Margaret Austin had her Sentencing continued until May 24.

Paul Creason was scheduled for Sentencing; although he was not in the courtroom. An arrest warrant is issued. There stands a \$15,000 bond.

Kale Murgel had his Sentencing continued until he could be in court. He will be sentenced on April 26.

Julie Humphries had a Sentencing on a charge of Guilty but mentally ill to two charges of criminal endangerment. She is Sentenced to Ct 1) Seven years DPHHS care, with four suspended. Ct 2) 10 years with five suspended to DPHHS care. There is a stay of Sentence execution of 90 days; in the hopes of her bed date at Galen/Warm Springs within that time period. She must check in to the County Attorney's office or BCSO twice a month until further notice. She must abide by all conditions as amended by the court.

## Water Rates, 1

Rauser said the city's engineering firm hoped to have the revised estimates by the end of March. She added that she would advise the council to move forward with rate adjustments as soon as practicable.

Lacking final numbers, the council did not take action on rate changes on March 20. However, it is likely they will revisit the issue at the April 2 meeting.

### Also at the March 19 council meeting:

- Al Christopherson of the Broadwater County Development Corporation (BCDC) presented a survey of Broadwater County trails, including those in and around Townsend. Through the mapping process, BCDC was able to identify a set of priorities for development, both for the county and city.

"This is a first shot at getting Townsend connected as a (transportation) system," Christopherson said.

The goal for the work is to create a master trails plan, tied to existing county master plans, including those for the fairgrounds and Silos area, Christopherson said.

While "trails" might imply recreational use, Christopherson said that when it came to trails in Townsend, the group looked at federal grants, particularly those related to access to critical infrastructure, including government, business, health care, schools, and evacuation centers.

As part of the process, Christopherson said he "inventoried all the sidewalks in Townsend. I can tell you there aren't many that go east and west."

That becomes a problem in the event of a disaster requiring the community's evacuation. The nearest evacuation center is at the Townsend Fairgrounds, which has no accessible pedestrian or bike route currently.

Sidewalks themselves were a central question for council members. Howick asked if Americans with Disabilities Act (ADA) compliance for sidewalks was included or planned in the review, as ADA does not allow for bicycles to be used on compliant sidewalks.

Christopherson responded that compliance was something to be looked at in a finalized plan.

Council members also inquired about the costs of installing and maintaining sidewalks, as current ordinances require

homeowners to be responsible for maintenance. Sidewalk maintenance has been sporadic at best outside of the city's main streets.

Christopherson noted that his group has discussed the possibility of developing endowments for maintenance, adding, "There are answers to do that".

A preliminary list of priorities also includes improving the trail to and from Indian Creek Road Campground, specifically adding a pedestrian river crossing; the six-mile loop on Centerville Road; trails in the Silos area; access to Copper City; and city trails for Townsend.

Christopherson said he would be presenting the survey to several groups before BCDC proceeds with planning, including speaking to county Disaster and Emergency Services, the Broadwater County Commission, and the Prickly Pear Land Trust.

- Owners of the FishTale and Commercial Bar presented an application to close Broadway between Front Street and Spruce for their annual Broadway Block Party, on July 13. The party would begin two hours earlier than last year's event, at 2 p.m., ending an hour earlier, at 1 a.m. After hearing comments from council members Howick and Angie Wintrow that neighboring businesses had not had the opportunity to provide feedback to the sponsors regarding changes to the closure proposal, the council asked the proposal be revised and brought to a later meeting with proof of support from affected business owners.

- Bob Ducker of River Oaks Communications spoke to the council via Zoom about considerations for putting telecommunications franchise ordinances in place for telecom providers using the city's existing right-of-ways and infrastructure for cable lines or other uses. The presentation positioned River Oaks as a potential contractor for negotiating with telecommunications providers in developing any ordinances. The firm would work with City Attorney Peter Simon, leveraging River Oaks' experience in telecommunications law and existing relationships with large telecommunications providers to develop ordinances.

With the county's population continuing to grow as well as existing recreational draws, "There's going to come a point when capacity is going to be maxed," Ducher said. "Planning

ahead for telecommunications companies to expand capacity is "proactive, not reactive."

Developing franchise ordinances should be a "collegial" process, Ducher continued. Franchise ordinances generally include compensation for the use of city right-of-ways and infrastructure.

Mayor Vickie Rauser asked about using a model ordinance from another community instead of going to the expense of hiring counsel.

Ducher noted that, while the council could do that and might find ordinances that met Townsend's needs, the risks of that approach include finding the right model in the first place and ensuring that telecommunications law hasn't changed since it was written. While federal law surrounding cable franchises is fairly settled, Ducher said. Those surrounding telecommunications and internet providers are "really in a state of flux".

"How common is it to have a consortium between a county and a city?" Howick asked.

"It would be ideal," Ducher replied.

Wintrow asked if ordinances could be applied to providers if the cable has already been laid in the city right-of-way.

Ducher indicated that ordinances could not be applied retroactively. However, the city might be in a position to negotiate an agreement with that provider, should there be another provider who wants to compete in the market.

City Attorney Simon will continue to work on the franchise ordinances, and the council took no action on River Oaks' informational presentation.

- The council received five applications for the open position of City Pool Manager. Interviews were planned to be held March 22-25. In order to open the pool, a manager would need to be in place by mid-April.

- Townsend Tree Board member Patrick Plantenberg updated the council regarding the hire of an independent contractor to water city trees. The council approved a contract for Teri Blahnik, who has maintained the city's trees for the past several years. Plantenberg noted that Blahnik's work could begin as early as the end of March, depending on the weather.

## Broadwater High School May Field Baseball Team in 2025

Townsend Schools Board of Trustees gave conditional approval to adding boys baseball as a high school sport during the board's March 12 meeting in a 3-2 vote.

The caveat?  
 Supporters must raise \$20,000 toward start-up costs for the program by July 31.

If the funding goal is met, trustees will contribute an additional \$10,000 for the first year, continuing the program beyond 2025 if it proves both popular and successful.

Trustees and administration agreed that the request to add the program comes at a time when the district is already facing tight budgets, with tighter financial circumstances expected as federal money related to COVID relief is no longer available.

When asked by board member Vanessa Flynn whether next year's budget could absorb the \$10,000 commitment, Superintendent Susie Hedalen replied, "It would require some shuffling. It depends on [certified and classified staff] contract negotiations. Something else might have to give."

"I don't want to commit to something we can't cover," Flynn said.

Board Vice Chair Chase Ragen, who made the initial and amended motions to add the sport, emphasized that adding baseball would provide another avenue for students to engage in school. He noted that it was not likely to draw students already participating in a spring sport, based on a

student interest survey.

Like the remainder of the board, however, he expressed concerns about the financial sustainability of the program. "The concern for me is 2026 and on-going," he said. Later he added, "We're going to face some tough, tough decisions."

Long-term financial concerns were underscored in the board's adoption of an amendment to the initial motion, requiring start-up funds be raised by the group spearheading the request to add the support. In the end, trustees Flynn, Ragen, and Jason Kool voted to add the program, with Board Chair Jason Noyes and Daniel Truesdell voting against.

"I'm forever going to be known as the guy who hates baseball," Noyes said. He emphasized that as a board member, he sees his role as focusing on academic achievement. Broadwater High School students have a broad offering of extra-curricular activities currently, Noyes stated. "And we certainly can't keep adding things to an already strained budget."

Speaking in a separate interview, long-time Townsend Youth Baseball coach and leader Gary Bauman said, as the point person for community members supporting the sport's addition, he's confident the group can meet the \$20,000 goal by the deadline. The group is already forming a steering committee and has a relationship in place with a 501(c)3 non-profit which will receive start-up funds (see sidebar for more information).

Start-up costs include uniforms and equipment, among other items. However, fundraising to meet the costs of offering the program is only an option for one year under Montana High School Association (MHSA) rules.

Bauman said the plan would be for games to be played at McCarthy Field, with practices to be held at a to-be-determined location.

Part of Bauman's confidence that his group will meet their financial goal stems from the number of Townsend-area kids already participating in the youth baseball program, which has 184 participants this year. Those numbers have grown consistently year over year, from 122 participants in 2021 to 141 last year.

By comparison, Manhattan, a larger community and school, has 84 youth baseball participants this year.

The Babe Ruth league team Bauman coaches for the local organization will have about 12 boys ages 13-15 this year. Bauman added that a meeting for current high school students interested in playing next year netted around 24 students. Over the age of 15, boys have limited options to continue playing baseball in the region. The primary option, the Gallatin Valley Outlaws American Legion team in Three Forks, costs \$2,700 for boys to participate, Bauman said.

This spring is the second high school baseball season since MHSA approved the sport. Currently, teams are split into four divisions with no distinctions for school size. Townsend would likely compete in MHSA's Eastern Division for the support, playing against teams from Belgrade, East Helena, Lone Peak, and Columbus, among the six teams currently in the division. With several Class AA schools planning to add the sport next year, MHSA may separate the largest schools into their own competitive division. That determination will be made at a later date.

## Commissioners to Revise Proposed Procedures, Application for Family Transfer Exemptions

In the face of strong public feedback to proposals to revise the county's family transfer exemption procedures and application, Broadwater County Commissioners decided on March 20 to send the documents back to the drawing board. Revised procedures and a streamlined sub-division application will be reviewed at a later meeting, once feedback has been incorporated.

Deputy County Attorney Kaylan Minor said her intent in making the initial revisions to the documents was to provide more clarity for those considering requesting an exemption from the county's subdivision process and to reinforce that "the county does have an interest in preventing abuses of the family transfer process".

At issue for many of those who spoke during public comment on the proposed documents was the list of potential questions an applicant might be asked during the application process or when a proposal is brought before the commission. Some of those questions ask about late mortgage payments and delinquency. Applicants would also be required to state under oath that they did not intend to evade subdivision regulations through the transfer process.

The list of questions, as well as their phrasing, "assumes nefarious intentions of doing a family transfer," Beth Ries of Triple R Surveying told the commission. Ries's sentiment was echoed by several of those who commented on the proposed procedure.

Bernadette Swenson of Townsend's Schauber Surveying asked the commission, "Is there a problem with people evading subdivision regulations?" She noted research she had done surrounding changes made to the regulations in 2019 that showed the rarity of property sales after family transfer in Broadwater County. "If someone is trying to evade, then [Montana Code Annotated – state law] allows you to prosecute them."

Commissioner Debi Randolph noted several of the questions "could be seen as personal financial questions" individuals might be uncomfortable answering under oath.

"There is no obligation to answer," Minor explained. "The intent is not to embarrass people but to get a holistic and comprehensive" understanding of the circumstances surrounding the transfer.

"Why are they in there as a baseline for you guys to make a decision" if applicants are not required to answer the questions, Jeff Schritz asked in public comment, also recommending those be removed entirely from the procedure.

"The reason these are here are so people can be prepared for questions that may be asked of them," Commission Chair Darrel Folkvord responded. "If they decline to answer it, that's fine."

Rylan Stahly of Helena-based Stahly and Associates surveying recommended several changes, including a pre-application meeting with the commission to determine if an applicant meets the criteria for an exemption before investing in surveying work and utilizing a sworn affidavit to confirm intent to comply with surrounding laws.

Commenters also raised concerns about the suggestion that applicants seek legal counsel prior to submitting an application for exemption.

"It's very unsettling," Swenson said of the change in the commission's tone toward exceptions in recent years. "No landowner should have to have a lawyer come in for every exemption they want to look into."

"We are not requiring anybody to come here with an attorney," Folkvord said.

"What happens often is that when people come here and they haven't talked to an attorney, they ask our legal department questions," Randolph said. "We cannot provide that." Commissioner Lindsey Richtmyer withdrew her original motion to approve the changes to the exemption procedure, pending changes based on public comment. "I think there were really good suggestions," she said. "We're walking a really interesting line with everything that has come down regarding subdivisions and water."

Minor also presented a summary of a revised exemption application, which condenses two existing documents. The revised application would include the option of requesting a pre-application meeting. It also requires that applications be made one parcel at a time for one exemption type.

Commissioners took no action on the revised application, asking that it, too, undergo changes as suggested by public comment before being presented for approval.

Also at the March 20 Meeting:

- Al Christopherson with the Broadwater County Development Corporation's (BCDC's) Trails Committee presented a survey of the county's hike- and bike-able trails and transportation routes. The work excludes existing trail systems on U.S. Forest Service and U.S. Bureau of Land Management (BLM) land.

The committee's goal is to create and implement a hike-bike master plan for the county that focuses on using existing trails to improve connectivity throughout the county, provide access to critical and emergency services, and offer healthy recreation and educational opportunities. It includes continuing a paddler's trail that currently exists from the Missouri River Headwaters to Toston Dam.

Priorities include a pedestrian way across the Missouri River at Indian Creek Road, Centerville Road from Indian Creek Road Campground to Canton Lane, north Harrison to the Fairgrounds, Townsend to Silos Road, including underpasses; Copper City Road, and Silos Road trail.

Other ideas include digitizing the original Lewis and Clark trail and making it available through Global Information

William James Bird (Jim), 83, of Townsend, MT, passed away in Helena, MT, on March 14, 2024. Son of William Hoyt Bird and Lucille Bird (Carter), he was born February 2, 1941, in Sydney, MT. Jim was number seven among nine children. They lived in Lambert, MT, until he was six months old, then went on to Kalispell, MT, where he attended and graduated from Kalispell High School in 1960.

After high school, Jim directly enlisted in the Army National Guard and was sent to Fort Sill, OK, for basic training. He served in the National Guard for approximately six years in various areas throughout Montana. He was an artillery crew member in the 154 Artillery where he advanced in rank to Staff-Sergeant. During his time in the service, he served in multiple positions. He loved to tell stories about cooking for the men. He said he was chosen often for KP because "Bird" was at the top of the list. He was a Training Sergeant, a CBR Warfare Specialist, a Sergeant of the Guard, a Squad Leader, a Platoon Sergeant, and an Acting First Sergeant. In 1963, Jim attended the University of Montana in

Missoula, completing three years of study in Wildlife Biology. He continued to study and learn all his life. Jim didn't complete his degree because Montana Fish and Wildlife offered him a position with them as Game Warden, including on-the-job training – starting immediately. Jim was a Game Warden for 29 years, and during that time served as Field Training Officer and Firearms Instructor before retiring. He found he wasn't ready to retire, so worked about three years for the Census Bureau and another ten years at the Helena Federal Reserve, before actually retiring.

Because of his position as Game Warden, Jim moved to Townsend, MT, where, through her father, Paul Hahn, he met Beverly Jean Hahn. They were married on September 13, 1969, in the Hahn Family living room. They purchased and ran a small farm. They were married for 54 years. Their children are Cory Bird and Eric Bird.

Jim loved fishing, hunting, fly-tying, gemstone faceting, gunsmithing, woodworking, hiking, playing softball, basketball, and loved living vicariously through his grandkids in sports and music. He loved children, telling stories, teaching the things he loved to others, and just being a good friend. He was a lover of people.

Jim was a Boy Scout leader, baseball coach, and taught Hunter's Safety courses for thirty years. He was a member of Mountain Valley Church, the Lions Club, and Jaycees.

Jim is survived by his wife, Beverly Bird; sons, Cory Bird (wife, Jennilee Bird) and Eric Bird (wife, Sarah Bird); grandchildren, Emily Bird, Tanner Bird, Tyler Bird, Benaiah Bird, Noelle Bird, Eowyn Bird, and Eva Bird. He is also survived by his sisters, Donnadell Sampson and Patty Keeler (husband, Ray Keeler); as well as numerous brothers-in-law, sisters-in-law, nephews, nieces and cousins.

He is preceded in death by his father William Hoyt Bird; mother-Lucille Bird; siblings Eugene Bird, Carol Searle, Marilyn Meyers, Robert Bird, Theodore Bird, and Michael Bird.

A memorial service was held on March 23, 2024, at Mountain Valley Church in Townsend, MT with over 200 friends and family celebrating his life.

System (GIS) feeds, so even boaters on the lake could see where they're at in relation to the trail.

Next steps for the committee include researching grants, developing memoranda of understanding, and finding funding for priority projects, as well as funding for the long-term maintenance of trails throughout the county.

- County Clerk and Recorder Angie Paulson gave official notice that, since fewer than three candidates filed Broadwater County Commission District 3 and Broadwater County Clerk of Court, those races would appear only on the November 5 general election ballot. Incumbent Darrel Folkvord and candidate Jesse Swenson filed for commission district three. Audrey Plymale and Kelsi Anderson filed for the open clerk of courts position.

- Representative Jane Gillette informed the commission about a Housing and Urban Development (HUD) Survey available on the Montana Department of Commerce website. The survey allows communities the opportunity to provide feedback on how HUD funds are used in the community.

- County Public Works Director T.J. Graveley spoke to the commission about items not accepted at county dump and transfer sites. These include oil, which can be recycled at locations in Helena, and paint, which can only be accepted as a solid. Responding to a question from Randolph, Graveley also said hours at the Cedar St. and Winston stations may be extended in early April.

- A Parks and Recreation board member summarized an email from board president Lacey Forrey to the commission. The committee meets with Great West Engineering on April 4 to begin scoping a master parks and recreation plan. Areas to be reviewed include Centerville, the golf course, and the acreage around Connors Field. The initial meeting hopes to lead to a cost for those priorities.


