## **Montana State Cross Country Championships**

The Montana state cross country championships took place Saturday at the University of Montana golf course in Missoula. More than 1100 runners (614 men and 527 women) representing 128 schools from all classes descended on the course with Class B having the largest fields of the day from 41 schools.

The Class B Ladies' race was the first competition of the busy day with 185 runners taking to the course. Sophomore Kyla Meissner powered through to finish in 2nd place behind Plains'

Marina Tulloch. Marina missed the all-time Class B state record by 3 seconds, while Kyla's time of 19:23.3 lands as the 6th fastest time recorded at the state meet in the Class B competition. She is right behind former Bulldog phenom Emma Stolte who logged a 19:18.91 in her state championship run her senior year 2021. Freshman Elaine MacDonald ran her personal best time of 20:14 to place 14th and secure all-state honors. Kaelyn Sangray (22:32) capped off her senior year finishing 50th, while sophomore Arabella McDaniel tied her PR of 23:05 to place 66th. Fellow sophomore Shalyn Sentinella improved once again with her first sub-25 time of 24:53 (PR) to end in 117th. Junior Logan Barkhurst (26:35 PR) and senior Grace Kroeger (27:40

SR) rounded out the team finishing 150th and 167th, respectively. The Lady Bulldogs finished in 9th place out of 21 scoring teams with 249 points.

The Bulldog men's team finished as a team in 12th place with 342 points among the 27 Class B teams having enough qualifying runners to tally a team score. First to cross the line for the men was senio, r Nolan Flynn, who ran a time of 16:55 to secure all-state honors by placing 14th in a field of 217 runners. Junior Gavin Green (18:17) finished in 45th place, while senior Kaden Bruins (18:57) ended in 69th. Sophomore Rylan Hoveland ran his personal best time of 19:23 to place 83rd, and fellow sophomore Luke Tullos (20:19) landed in 131st. Juniors Patrick Gossard (21:11) and Keaton Cavasos (21:32 PR) completed the team in 166th and 174th. Keaton managed to cut 33 seconds off his previous PR on a demanding course.



in electronics during his stint in the service. While he was waiting for a job opportunity, he leaned back on his teaching certificate to win a job teaching high school science in Hawthorne, Nevada, a town of 6,000.

While teaching he used the GI Bill to earn a Master's degree in administration. He received his degree in 2000 and immediately took a job in Hawthorne, Nevada as the Middle School Principal. In 2007 he moved from Hawthorne to the larger city of Elko, Nevada to take a job as the principal at a large elementary school. He was an administrator in Elko until this year when he retired and moved to Townsend.

Steve is open and easy to talk to. I asked what prompted him to become a teacher. He explained "It all started with Mrs. Masolo, my third-grade teacher. I was kind of shy, but she really made me feel important. She put on a play, Smokey the Bear and the Careless Campers. I got to be a camper. Mrs. Masolo allowed me to be more than I thought I could be. I never forgot that. Later I wanted to be just like her so I could give students that same encouragement."

Steve pointed out that his predecessor Principal Christina Hartmann had made great strides in good educational programs for the K-8 students and while he has appreciated being able to settle in on programs already in place, he wants to emphasize the importance of prekindergarten and kindergarten learning as a good foundation for school preparation. "Half of those programs must include the social and emotional component. The students must begin to learn in a structural environment when they get to first grade. So, learning to be polite, to play fair and to get along with others is so important. That way the door is wide open for them to focus on learning later on."

He explained the end goal is to challenge students to learn at high levels. When the students struggle a little, like in math, they learn more. The end goal is to help them order their thinking so they can solve problems in all situations, not just math, or science. He explained it this way: In one of his classes he had the young students write a recipe for chocolate chip cookies, then prepare the cookies as they wrote the recipe. "Right away, they could see they had the directions out of order, forgot to turn on the oven, left out the sugar- it was a fun way to teach them the importance of order." He laughed.



The criminal docket in Judge Christopher Abbott's courtroom on Friday, October 25 is as follows:

Jessica Guillermo had an Initial Appearance and Arraignment; pleading Not Guilty to criminal endangerment and aggravated DUI (3rd) and open container. Omnibus is due December 6; Pre-Trial is set for March 28, 2025; with the Jury Trial scheduled for April 21.

Michael Taylor was found guilty of DUI in Justice Court; and is appealing that conviction in District Court. Omnibus is due by December 6; Pre-Trial is set for March 28; with the Jury Trial scheduled for April 21.

Edward Mierow had a Sentencing on a charge of criminal possession of dangerous drugs (meth). He is Sentenced to 4 years deferred; to run concurrently to his charges in Lewis & Clark County charges. He must have a chemical dependency evaluation and enroll in Treatment Court; pay \$80 fees and surcharges, as well as pay a \$300 Public Defender fee.

Kyle Mostad had a Petition to Revoke on a firearm charge. The Federal trial is delayed. He is Sentenced to seven years D.O.C.; with 748 days credit "street time"; with 5 years suspended. He must serve 90 days in jail, in 14-day increments.

Asad Khan appeared for a Motion to end Supervision; after serving eight years on a 12-year suspended sentence. He has paid restitution to the McFerrin family and paid all fines. The judge granted him a conditional release; but if he receives a revocation in the next four years, he will have to spend four years at Montana State Prison.

Jeremiah Howe appeared for Sentencing on a Plea Agreement; after a trial jury came back as 'hung' demanding a mistrial on charges of sexual assault (s) on minor(s). Judge Abbott said that he believes what the children told the Court during the Jury Trial. Per the Plea Agreement, he has pled guilty to assault on a minor and two counts of partner/family member assault. He is Sentenced to six years deferred, with no early release. A new psycho-sexual evaluation is ordered. He is not to contact the three victims, nor get within 1500 feet of them. The Pre-Sentence Investigation fee is waived, but he must pay fees and surcharges of \$80. He must attend Behavior Modification Therapy, Moral Recognition Therapy and Batterers Education (with those completed within two years). He must follow all other conditions.

## **County Elections Activity Update**

#### Reporter



Election activities continue to move forward in Broadwater County since the October 11 mailing of absentee ballots. According to Elections Administrator Angie Paulsen, 53 percent of all the ballots mailed from her office have already been returned and accepted.

With less than a week away from the election, the county's return percentage is higher than the final primary election return results received in June. Paulsen is hoping for high ballot return numbers for the approximately 6,000 registered voters in the county.

Paulsen's office sent out 3,705 absentee ballots, some of which have been returned undeliverable, due to various reasons such as voters not updating their registration or the voter is deceased. She has also been fielding calls from voters who want to register past the October 7 registration deadline. She explained: "Voters can still register until election day,

November 5, except noon-5:00 p.m. the day before the election, but they must come in person with their identification. Otherwise, registration by mail is closed."

Paulsen said polling place volunteers are trained and ready to go. Thirty-five people will work the polls in Toston, Winston and at the school. They have had extensive training sessions earlier in the year in preparation for the primary and general elections. These volunteers are prepared to work the long hours of election day from 7:00 a.m. to 8:00 p.m. when the polls close.

While Paulsen has had some crank calls questioning the process in Broadwater County, she has been able to assure people the election will proceed without a hitch. Once the ballots are received Tuesday night, the work is just beginning. After she reconciles all precinct ballot certification reports, she will report the official count to the Secretary of State's office.

Paulsen and her office employees begin the procedure to ready the ballots for the official audit by the post-election audit committee which hand tallies each vote from randomly selected precincts, candidates and initiatives chosen randomly at the state level. The audit committee then compares the tallied votes to the election day machine totals. This audit will take place at the Flynn Building on November 14 beginning at 8:30 a.m. The official general election canvass begins Monday, November 18 at 9:00 a.m. also in the Flynn Building. Both activities are open to the public.

Paulsen pointed out every voter received a Voter Information Pamphlet in the mail. The pamphlet explains the ballot initiatives CI-126, 127 and 128. If voters did not receive a pamphlet, they can pick up one at the elections office in the courthouse or access it online at https://sosmt.gov/electins/vip/. If a voter has questions, please contact Paulsen's office at (406) 266-3405.








year ago today our enemies laid down their arms in accordance with an armistice which rendered them impotent to renew hostilities, and gave to the world an assured opportunity to reconstruct its shattered order and to work out in peace a new and more just set of international relations".

On June 4, 1926, Congress drafted a bill, signed by President Calvin Coolidge issuing an annual proclamation calling for the observance of November 11 with appropriate ceremonies. Again, on May 13, 1938, a bill was signed into law by President Franklin D. Roosevelt, declaring November 11 a national holiday, and Armistice Day was born. World War I was often called "the war to end all wars", but that peace was shattered just a little more than a year after the creation of Armistice Day, when on September 1, 1939, Germany invaded Poland and World War II began. After the war, World War II veteran, Raymond Weeks, came up with the idea to have Armistice Day recognize all veterans, rather than just those of WWI. Weeks led a delegation to Washington DC to propose the idea, and it was well received by President Dwight D. Eisenhower. US Representative Ed Rees from Kansas presented the bill, and it was signed on May 26, 1954, by President Eisenhower, also from Kansas. Finally, on June 1, 1954, an additional bill was signed into law changing "Armistice" to "Veterans" and the day has been known as "Veterans Day" ever since.



## When Things Go Right!




In between rain/wind (or whatever Montana's weather sent our way) I got my regular weekly chores done earlier than usual. I won a football board; I used



## The Science and Art of **Grazing Small Acres:** Part 2 The Art

M part of a miniseries on the science and MONTANA art of grazing livestock on small acres. EXTENSION If you are new to owning property and/ or livestock, you may discover there is a steep learning curve when it comes to land stewardship. Even if you have owned property, the environment and conditions in Broadwater County are vastly different than other areas of the country, even different than other areas of Montana. There is a large amount of science behind grazing management. However, there is also an art to grazing that takes some trial and error to determine what works best for your property. Last week, I focused on the plant biology of grazing and this week will be on the art, the specific strategies to help you manage grazing.

One of the best strategies you can do is to develop a sacrifice area. This may sound counter initiative but hear me out. As I hopefully established last week, it is not realistic to graze livestock year-round on small acreages in Montana. It is critical to allow a rest period for your pasture to restore its energy reserves and regrow. Therefore, if you establish a sacrifice area, it will help keep your pasture in better health. This can be a small paddock, dry lot, corral, barn, stall, etc. where you are okay with complete grass loss. It is called a sacrifice area because this grass is 'sacrificed' so that you will have grazing accessibility on at least part of the year on the rest of the property. To be clear, the sacrifice area should not be your entire property.

Consider dividing your property into small units. Grazing isn't the only action by livestock that causes harm to plant communities. You will also lose forage to trampling, soil compaction and manure buildup. If you divide your pasture into smaller units, it will allow you to utilize a rotational grazing system. There are many benefits to rotational grazing and a large amount of research about how to implement them (oops, talking about science again). Rotational grazing allows you to increase the rest period between units, reduce trampling and compaction, and avoid excess manure building. When done correctly, it will increase forage production and is a win-win for everyone.

Sometimes it's not possible or practical to do rotational grazing. Another strategy is limiting the animals' use of the property each day. For example, turn them out for two hours (or less) every day. This still allows you access to the forage, reducing supplement costs, but allows to you to have more control of their grazing access. When you start to reach the threshold (take half,

leave half), its time to reduce the turnout time or stop completely to allow the pasture to regrow.

Time of year matters. It is natural to want to graze livestock when grass is green and growing. And it makes sense in many regards because this is when grass has the highest nutrient content (sorry, more science). As the grass matures, nutrient quality decreases. However, plants are most sensitive when young to overgrazing. Allowing plants to mature and gain strength during the growing system will make them more resilient to grazing. If you graze the plants in the winter while they are dormant, they can withstand heavier grazing (within reason). As an added bonus, winter grazing means less chores when the weather is cold! It is important to note though that some animals may need additional supplementation due to decreased nutrient content in the winter, especially pregnant, nursing, young or elderly animals.

Be prepared to supplement year-round. Don't wait until you are out of hay to buy some. Drought years can sometimes catch us off guard and you don't want to be caught without hay and put into a situation where you are forced to overgraze due to availability or cost of hay or supplements. Always have some on hand so you have the flexibility (here's to the art) to adjust your grazing management plan as needed throughout the year.

Ultimately, grazing management takes trial and error to figure out what works best for your property and livestock. When grazing management is done correctly it can provide benefits to the land including stimulating growth, removing dead plant material, reducing wildfire threat, increasing nutrient cycling and increasing forage production. However, when land is overgrazed, it can lead to many issues including the prevalence of weeds, increased use of herbicides, poor forage quality, lack of plant diversity, reduced land value, and increased erosion, water runoff and nutrient leaching. Don't wait until it's too late to seek help and finetune your system.





Once he received his commission as a 2nd Lieutenant, he was assigned to the 190th Combat Sustainment Battalion (CSB) in Billings as an S-2, Military Intelligence Officer. After completing his Basic Officer Leadership Course

(OBC) he went down to Fort Huachuca, Arizona where he learned all about the Intelligence world.

Clay is in the Montana Army National Guard and is an Active Guard Reserve (AGR) member. He held a position at Joint Force Headquarters as the Intelligence Officer and Aviation as the S-2 (non-flyer).

In October 2019 Clay deployed with the aviation unit as the intelligence officer to Kuwait, Saudi Arabia, and Iraq, and arrived home in October 2020.

After that, he was given a command position with the Chemical Recon Detachment (CRD) of the 19th Special Forces Group. Clay commanded the unit for almost three years.

After that time, he accepted the Assistant Professor of Military Science (APMS) position with Carroll College ROTC which is the officer in charge of Carroll College. The ROTC unit there is probably the second-best and biggest in Montana. He relinquished command at the CRD in 2023 and totally focused on the ROTC. Now he is enrolled in a Master's degree in Higher Education Administration through the University of Lousiville.

In June of this year, he was command-directed to be in current operations officer of G3 operations cell at Joint Force Headquarters.

Clay said he had had many mentors during his career. Clay has been in the military now for 12 years. Right now his packet is up for promotion to Major, and waiting to Scroll. The Scroll process means that you go through all of the departments of the DoD, to check off that you meet requirements before you are promoted.

Clay reflected back on his career. "It has been a very fruitful and blessed career. I think every day I learn. That never stops. The day it stops is when I probably shouldn't be in the military anymore. I have 8 years left if I want to retire on the National Guard side, but I have 14 years left if I want to retire on the active-duty side as long as the timing with my family would work out right. Speaking of family, you are gone a lot, whether it is going to work every day, or annual training, deployments, or the schools you have to attend. I don't think a lot of people realize how much military families put into it. There is a lot to be said about a family, especially mine, they always put their best foot forward at those times. I try to do what's best for them. I think the resilience of the military family is something to be said. I owe a lot to mine, I was able to do the things I did successfully because I knew they were OK here and my wife, as strong-willed as she is, could handle it. There is a lot to be said for that."

#### **RESPONSE TO TESTER AD**

I am writing to address a recent Ad put in the Local MT 43 News Paper (October 25th, 2024) edition. There is a full-page ad stating that Senator Jon Testers secured \$255,943 for the Broadwater County Sheriff's Office. I would like to set a couple things straight.



First off, the Broadwater County Sheriff's Office does not endorse any candidates.

Individuals can endorse who they please. The Ad came across to me that the Broadwater County Sheriff's Office supports/endorses Jon Tester. As a Sheriff's Office we do not endorse any candidates. We have a duty to serve and protect the citizens no matter what political party someone is associated with.

Second, the money the Ad is referring to comes from two different sources. In 2020 when a Mill Levy was passed by the Broadwater County residents, the Sheriffs Office vowed to apply for a COPS grant from the federal government. That grant is \$125,000 per new Deputy spread over 4 years. After the 4th year the Sheriff's Office has to have the funding to maintain the new employee full time. The Sheriff's Office applied for 2 grants, hence the \$250,000. That grant is over 4 years old. As far as the other \$5,943, we do everything we can to lower the burden of the tax payers. There is a grant available to reimburse partial amounts for a new bullet proof vest. So, when we get a new vest we apply for the grant. Over the last few years we have received \$5,943 which is a third of what we spent on new vests.

It is unacceptable to me, for the Broadwater County Sheriffs Office to be used as a political puppet. We were never notified that the Ad would be in the paper or asked for our permission. Jon Tester has never reached out to the Sheriff's Office or myself. The COPS grant was written by Undersheriff Harris, and Sheriff Meehan at the time was the one who had to maintain it and stay compliant. All the support we have received has been from the citizens of Broadwater County. So, Thank You to the citizens for the support, and if you have any questions please call me.

at campaign events in Shelby and Hamilton last November. Sheehy, a recent Montana transplant, was recorded saying he ropes and brands with Crow members, and that it's "a great way to bond with all the Indians while they're drunk at 8:00 A.M." He further claimed to have had "Coors Light cans flying by your head" while riding in the Crow parade. The Char-Koosta also reported that in separate events in Superior and Helena, Sheehy said Crow tribal members called him 'white boy,' and threw Coors cans at his head at their rodeo. Mr. Sheehy shared these damaging stereotypes to his largely white audiences as representations of who we are as Indian people, apparently thinking he could elicit some laughs about his experiences in tribal communities. We aren't laughing.

CSKT's Tribal Council stands in solidarity with the Crow Tribe who were on the receiving end of Sheehy's remarks. Our elders have described his words as hateful and we listened. Sheehy said nothing of the many great achievements in our communities, of ever-increasing numbers of Indian people making their way through college to earn advanced degrees, to learn our languages and culture, and support our communities. Our community battles high suicide rates especially among our young people who should have their heritage honored, not disparaged by someone who wants to represent us all in the U.S. Senate.

Has Sheehy responded to any media questions regarding his words? He told one Fox News reporter that the audio clips were chopped up to make him sound evil. What he neglected to say was any sort of condemnation for those sentiments that came out of his mouth. Does he wish to be a friend to the Native populations he's asking to represent? Does this ex-Navy Seal realize the harm he has inflicted upon the many Indian veterans in our communities?

We have listened to the full audio of Sheehy's speeches that were recently released by the Char-Koosta News after their reporting was questioned, and Sheehy's hateful rhetoric is just as unacceptable as it was before.

Montana has come a long way since the Lewis and Clark party encountered the Native peoples. Sheehy shows us we still have a long journey ahead to heal these divisions. This Council looks forward to hearing what you say next about your words. Your silence so far has already told us volumes. And for those affected by these hateful, racist, and discriminatory words, we encourage you to step forward and make your vote count



The Governor stood in a drizzling rain on the by-pass over the head gates of the great canal surrounded by both sides of the ditch by visitors and homeguards and with a smile lighting his face he dedicated the new \$900,000 diversion dam to posterity as a memorial to those men who over a period of 50 years had worked for the feat.

## **Reading Leaves Nook Improvements**

You may be wondering what is going on at Reading Leaves Books with all of the activity in the parking lot lately. The

wooden fence is part of a much larger project that will be finishing up over the next few weeks.

In February 2022 Reading Leaves Books, in conjunction with Broadwater Community Development Corporation (BCDC), was awarded a Main Street Montana Grant. Main Street Montana is a subsidiary of the Main Street America Program which "awards competitive grant funding to communities focusing on planning and/or implementation projects directly related to downtown revitalization, development, and historic preservation." The grant has a community match of 20% which was met with a Town Pump Community Grant, and community donations. We also received supply donations from Jacob Weaver and Kenyon Noble Lumber.

The purpose of this grant was to turn the covered storage space on the side of the building into a reservable community space, add an ADA-accessible restroom, and



finally, turn part of the parking area into outdoor seating. The interior is being insulated with finished walls but will not be heated. There will be a mural added to the interior brick wall. The outdoor space will have tables and chairs with umbrellas and planted greenery in raised beds to bring some color and comfort to the corner. The fence gives some separation from the highway while visitors relax and visit.

The work has been completed by many local contractors including Special K Plumbing, A da Z Concrete & Badger Materials, BSE Excavating, Baldy Mountain Homes, EIDSE Enterprises, Townsend Power,
